<u>General Service Conference Workshop-</u> The workshop topic at the General Service Conference is *Safety in A.A.: Our Common Welfare*. Insight is needed on this topic from members in Area 8. Questions that all delegates will answer are:

- How can we make our Home Group a welcoming and accessible place?
- How can sponsorship aid in keeping our A.A. meetings safe?
- In keeping with the Traditions, how would/does my group address matters that may arise, such as:
  - Conduct that disrupts the meeting
  - Illegal activity
  - o Inappropriate behavior toward vulnerable new members (e.g. "13<sup>th</sup> stepping)
  - Emergencies (injury/accident/fire/etc.)

Please share this topic and the questions with your district and committee members this month and ask if they can encourage sharing at their groups. There will be open microphone time at the assembly for sharing on this topic so that the Delegate can collect the views of our groups.

### Chairperson's Report: Jane G.

Reminder that this disease is as active and deadly and ever. Following up on last month's message about what to do about "Dark Groups" – groups that have no active GSR-Guy shared about how his district makes a group visit.

Dist 3, Guy, says his group visits have been moderately successful. They recently visited 2 groups and were able to get one GSR to step up. They use approved literature and made an announcement in the meetings. They take a pamphlet that was conceived and created by the district. They take a packet with the pamphlet reminding members about Dist 3 meetings and the "pie chart" sheet, with the GSR pamphlet. They might have a discussion with the secretary of the meeting ahead of time. We go in 2s and we are very positive and introduce ourselves to the secretary and ask for time afterwards. "Let the group know you are from the district and you have info to hand out. We give the info to the secretary if no one comes forward to accept a position as GSR. We stay afterward to answer questions. We decide ahead of time which meetings need a visit and divide and conquer." Guy also said that each part of the dist meeting is talked about such as what they were planning and how it was going. There is service material that asks, "Is your group linked to the group as a whole?" They take the new group form and the change of address form to the meeting.

Currently they have no translated forms but it being worked on. You might be met with opposition but take that in stride. Conversation is the best remedy. Show up and it works.

The Chair reminded us that if we get the GSRs to attend the District meetings the rest will follow.

#### **AREA COMMITTEE BUSINESS**

#### Registrar

Monty: The registrar is responsible for keeping a current list of all our groups. Every group has a number and this number does not come from Central Office. The number from the area does not correlate with Intergroup. If a group does not have a number the group does not exist as far as General Service is concerned. Visiting groups which are listed in the Meeting Schedule but not appearing in the Area's registry is vital. When a group has an area number but does not have a GSR it is like that group does not exist. When making announcements at any meeting that does not have a GSR be brief. Bring pamphlets and only hit target points—Informative but not talkative. If a visitation takes place, please share about how the "meet and greet" went. Keep an index card file of the meetings that need visitation. Spread the cards face down on a table and have GSRs choose one card and let the visitations begin. It is recommended that visitations take place in pairs or more. Elect a registrar for your district and that person could be the lead on this trek. Set that meeting up to be visited in 2 months. Once again, promote their attendance at the District Meeting.

Discussion: What takes GSO, New York so long to register new GSRs? Monty will research this delay. Districts can send their new GSR information to New York immediately. If you go on the Area 8 Website you can download a copy of the GSR pamphlet.

Ad Hoc Committee for Area Inventory: Jane working on this. Once we have a single document it will be send to the Area 8 website. No action was taken from the last inventory that was made in 2008. Area not serving the young people and elderly. Also some newsletter suggestions for collaboration. Info will go to committees ...
