The Ad Hoc Committee felt many AA members may not be aware that they can attend Area Assemblies. They also made reference to the General Service manual page S37 that states the following:

"Any AA member may attend, and in many areas members are encouraged to attend assemblies as a way of encouraging them to become active in General Service."

When we looked at the original text it didn't have anything about them being non-voting members.

Current Text:

- B. Non-voting member of the Area Assembly: Past Delegates of the Area Assembly have "ex-officio" non-voting status. Proposed Text:
- B. Non-voting members of the Area Assembly:
 - 1. Past Delegates of the Area Assembly have "ex-officio" non-voting status.
 - 2. Any AA member may attend and participate in discussions although they do not hold voting status.

(Adding a line into the guidelines.)

Motion re: Prudent Reserve

Gary read from correspondence maintained by GSO and from Conference Approved A.A. Literature in support of the motion.

** The SD Imperial area establish a \$2,500 prudent reserve, requiring substantial unanimity from area officers and Does this committee make that decision or the area officers and alternates?

We are open to a friendly amendment to this

Discussion:

(Continued discussion from last month)

- Everything is important for our area but our finance committee needs people. Is it more important to establish a prudent reserve or bring people to the finance committee? Where are our priorities? Our standing committees are more important than this motion.
- ♦ Warranty 2 of the 12 Concepts is all about Bill W's recommendation that we have sufficient operating funds and a prudent reserve. I think it is a wise thing. We should look at this.
- When I came up through service...I was raised in service that had set in place a way to deal with Area needs. When we needed money we asked the groups for it. When we did this we had never been denied. This set in motion our principle of corporate poverty.
- I suggest we move this to the area assembly. All we can do is send it to the groups to decide whether or not we have a prudent reserve. It's not the place of this committee.
- For new people: We are carrying out our duty to recommend or not recommend this motion to go to the Area Assembly. Regarding the motion, towards the end, there was concern about our area already having a prudent reserve. We evaluate the budget quarterly (25% rule) to see if our income has surpassed our budget and the question is why are asking for a prudent reserve when we already have a system in place.
- Operating reserve is different than a prudent reserve.
- ♦ I believe the original motion was to replace F1 and F2.
- ♦ That was a misunderstanding.
- ♦ We could change the wording for clarity.
- What I remember is that we were talking about allowing area committee access to a larger amount of accessible funds for operations. I feel there is a need for a higher limit for use here at the committee. Change wording to "discretionary funds" ...
- ◆ I believe that is another motion. Discretionary funds are different than a prudent reserve. Is there money available at any time? We look towards a prudent reserve for this purpose. Bill Ws take on prudent reserves speaks about the need to stay solvent. When available it is made good use of. It applies at every level. I have learned from my mistakes and we learn here too. I read about it at great length and this idea runs all the way through our groups. Corporate poverty does not mean walking around without a prudent reserve.
- ♦ I believe a prudent reserve is only to pay for rent and operating expenses, for one month. Then you go back to the groups and ask them. It is not an amount made up.

- I understand with our current funding that we are not even supporting our budget right now. We need to know how we are going to populate our fund. This assumes that capital is available. Our finance committee chair and treasurer report that money does not exist.
- ◆ Any time a need arises we have always gone back to the groups. I was schooled by past finance chairs about the way corporate poverty works. If we would adjust our fiscal year from Oct. to Oct. we would not have this problem. Our operating account exists so we would be in the 2nd quarter and we would be accountable to the groups. This is more of a buffer between the ACM and the groups.
- ♦ Can you give me an example how this would help us?
- ◆ ASL is a great example. If we had had a prudent reserve and we didn't have time to go to the assembly. We could have gone into the reserve and used it to fund ASL. The committee would have told the assembly that we used the money and for what. It is a stop-gap measure until we have the funds. It is mostly for unbudgeted or unforeseen expenses.
- ♦ Notes from last month refers to a friendly amendment to go back to leave F1 and F2 as is. Disbursement of funds for unbudgeted expenses was ...
- ♦ Return to page 9 of last month's minutes.
- ♦ Motion not to recommend...
- ♦ Call the question. Seconded.
- ♦ Have we had sufficient discussion on this?
- If we are only deciding whether to recommend then we are ready.
- ♦ We are voting whether or not to vote.
- ♦ 18 for and 6 Opposed to voting.
- There is more flexibility. It is the chairperson's responsibility to control the meeting...so that we have ample discussion before voting.
- There are too many people that are taking the motion in too many directions.
- I think that we are calling the question because we are tired and want to go home.
- ♦ The chair has the responsibility of the direction of the committee.
- ♦ We have the interest of the groups at hand.
- We started with entertaining a friendly amendment...we need to close or call the question. If we can't stay focused we need to end things here. We are only confusing each other. Can we get back to the topic? We need to clean it up. We've called the question and voted. Let's get it back to the question.
- ♦ There is insufficient information.
- If the motion has merit we will find it through the group conscience method. If the issue is so confusing it will be sent and not passed.
- ♦ We will adjourn.
